A. WHAT ARE COOKIES AND OTHER TRACKING TOOLS?

Cookies are small files stored by most internet browsers that track visitor information and enable For to make its web offerings more relevant to you. During your visit to our website, For uses four kinds of cookies. Their retention period depends on each country and the applicable law.

Other tracking tools are any 'passive' tracking tool, such as fingerprinting, web beacons (invisible pixels or web bugs), cookie "flash" (or shared objects), or any technology that helps to identify the user's device or operating system by collecting all or part of the information on the specific user-selected configuration of that device.

B. WHAT COOKIES DO WE USE AND WHY?

- Strictly necessary cookies: these cookies are essential for us to provide you with the basic functionalities of our website and cannot be switched off in our systems.
- Performance cookies: these cookies allow us to count visits and traffic sources to measure and improve the performance of our website.
- Functional cookies: these cookies provide enhanced functionality and personalization during your visit.
- Targeting or advertising cookies: Our advertising partners may set these cookies on our website to build a profile of your interests and propose relevant ads. Currently, we are not using any targeting or advertising cookies at Sennheiser.

Some cookies used by our websites are set by us, and some are set by third parties on Sennheiser's behalf.

It is set after visitors have seen a cookie information notice and in some cases only when they actively close the notice down. It enables the website not to show the message more than once to a user. The cookie has a normal lifespan of one year and contains no personal information.
btb.sennheiser-hearing.com	Strictly Necessary	OptanonConsent	This cookie is set by the cookie compliance solution from OneTrust. It stores information about the categories of cookies the site uses and whether visitors have given or withdrawn consent for the use of each category. This enables site owners to prevent cookies in each category from being set in the users browser, when consent is not given. The cookie has a normal lifespan of one year, so that returning visitors to the site will have their preferences remembered. It contains no information that can identify the site visitor.
cookiepro.com	Strictly Necessary	__cf_bm	This cookie is set by the cookie compliance solution from OneTrust. The __cf_bm cookie supports Cloudflare Bot Management by managing incoming traffic that matches criteria associated with bots.
.sennheiser-hearing.com	Performance	_ga	Used by Google Analytics to identify and track an individual session with your device.
.sennheiser-hearing.com	Performance	_ga_RYMNEYHYMT	Used by Google Analytics to identify and track an individual session with your device.
